Any divergence from these General Terms and Conditions of Sale and Supply is valid only if they are also included in writing in the order acknowledgement. These General Terms and Conditions of Sale and Supply shall also apply when Customer's are buying goods on their verbal orders either over telephone or verbally informed to our salesmen and Customer representative receives goods signing on ENCO TOOLS & EQUIPMENTS Tax Invoice / Challan or if goods delivered to them by Courier and ENCO TOOLS & EQUIPMENTS Tax Invoice / Customer's representative signature on ENCO TOOLS & EQUIPMENTS Tax Invoice / Challan, or a Courier A.W.B. / POD copy duly acknowledged by Customer's firm / Organization. Disputes- if any shall be subject to Mumbai Jurisdiction only.

### Offers, contractual documentation, conclusion of the contract 2.

- Any offers made by ENCO TOOLS & EQUIPMENTS are subject to change, Pricing. photographic and typographical errors are subject to correction. A contract shall be formed only when the order has been acknowledged by ENCO TOOLS & EQUIP MENTS
- The details given in offers, brochures and other written material (illustrations, drawings, specifications on performance, weights and measurements etc.) are only to be considered approximations. Notwithstanding any express agreement to the contrary, such details do not constitute warranted characteristics.

  Due to constant development work at manufacturer's end, manufacturer's reserves
- the right to change dimensions and other technical specifications as well as the range of products, without any prior notice.

- 3.1 Unless specified, quoted prices are valid only for 30 days from the date of quota-
- All prices are stated each per piece unless specifically marked against sale of promotional kits. These prices are stated exclusive of packaging, freight and insurance costs and also exclusive of VAT / CST at the statutory rate in force on the invoice
- Prices are based on the current price list of our principal / manufacturer and are based on prevailing rates of taxes, duties, excise, levies, freights etc. thereon. Enhancements therein, if any may increase the cost. Therefore we reserve the right to charge
- the price valid at the time of supply unless & until mutually agreed upon.

  Discounts marked in the quotations are as per the current sales quarter's promotion schemes from our principal and these discounts / special promotional prices may vary in subsequent sales quarter as per the revised / valid promotion schemes released by our principal for the particular sales quarter.

  Discounts marked in quotation are also valid only for the particular product category
- and minimum order quantity (MOQ) quoted for the particular item.

## Payment Terms, Credit Policy.

- Our normal agreed credit period is as follows and as mentioned in our Tax Invoice /
- Challan under Payment Terms is only applicable. Our credit period is Agreed credit period / payment terms will be for particular contract / order / transaction only and will subject to change by our credit control department based on customer's payment history
- ENCO TOOLS & EQUIPMENTS accepts Visa, Master, American Express Credit Cards, Cash (also refer 4.4), Bank Pay Orders, Demand Drafts-Payable at Mumbai, TT, we also accept company cheques and for the customer's who are not registered under ENCO TOOLS & EQUIPMENTS open credit accounts, the supplies will be effected only on the realization of the cheque amount.
- Businesses wishing to purchase on open credit terms must submit a completed credit application to ENCO TOOLS & EQUIPMENTS for review. Ask our office to fax or mail a credit application form to you or download from Enco web www.encotools.in you should complete and return the credit application to ENCO TOOLS & EQUIPMENTS for review. The review process is dependent upon the information provided on the application, and may take as long as four weeks, depending upon how quickly your bank and trade references respond to our enquiries. Completion of ENCO TOOLS & EQUIPMENTS credit application does not guarantee or imply approval for purchase on open credit terms. Approval and credit limit are dependent upon the information we receive from your bank reference and / or trade references of each customer business requestor.

    Our Credit Team will review your completed application upon receipt and advise you via mail / fax regarding our decision, the status of your account, and any applicable
  - credit limit.

    Meanwhile, we recommend making your purchase using an alternate payment method, such as credit card, bank pay order or demand draft-payable at Mumbai, TT, and cash. We do not allow cash transaction for any purchase over Rs.20,000/- and cash transaction is valid only if the ENCO TOOLS & EQUIPMENTS Tax Invoice has a revenue stamp on it and signed by ENCO TOOLS & EQUIPMENTS authorized signatory who has signed that particular Tax Invoice.

    Timely payment is of the essence of transaction and the transaction through our Tax
- Invoice is entered into on the clear understanding that the buyer / customer / purchaser agrees to make the payment not withstanding any dispute or counter-claim. In case of delay in the payment for any reason from the buyer / customer / purchaser from the agreed credit period or if the buyer / customer / purchaser dishonors any cheque accepted by ENCO TOOLS & EQUIPMENTS then ENCO TOOLS & EQUIPMENTS shall without prejudice to any other rights to be entitled:
- to demand immediate payment of all outstanding accounts. to withhold delivery of all goods or supplies relating to as yet unfulfilled contracts / orders. If the customer is not willing to make payments on a reciprocal and simultane-
- ous basis.
  to cancel all future extensions of open credit and all further business will be effec-
- tive only on realization of cheque payments against our proforma invoice, or through credit cards, or against receipt of bank pay orders, demand draft-payable at Mumbai, TT, Cash or dispatch documents through bank.

  ENCO TOOLS & EQUIPMENTS shall also entitled to impose an interest charge as damage caused by delayed payment at the rate of 22% per annum on all outstanding amount from the date of default. Furthermore, ENCO TOOLS & EQUIPMENTS is entitled to claim from the buyer / customer / purchaser all legal expenses incurred for the recovery of outstanding.

- The delivery period quoted is given in good faith and we shall not be held responsible for delays which are due to circumstances beyond our control. The delivery period as mentioned in quotation shall be deemed to commence after the receipt of technically and commercially clear purchase order with us including the approval of drawings, if any, to enable us to process the items further in our supply schedule.

  Delivery promises in quotation or verbal over phone is not guaranteed and will be
- extended by any delays occasioned by causes beyond our control including (a) computer or electronic interruptions, mechanical or electrical breakdowns, power cuts, strike or lockout, fire or any accident at works or during transit or other consequence of war or riot or political or other disturbances, severe weather conditions, act of God, or any other forces beyond our reasonable control. (b) Delay in inspection and or approval of goods offered for inspection as per order terms. (c) Non compliance with the terms of payments. ### Passage of risks and acceptance of goods.

- tions of packing etc. should be brought to the notice of us in writing within 48 hours in case of local Mumbai, Navi Mumbai and Thane deliveries, and within 7 days from the arrival of goods at destination for outstation Customer's. Any delay in the cases

  We are not responsible for any loss or damage occurred to the Customer if the product is- altered, modified, or abused by Customer's. Not following the user guide / machining instructions provided in the manufacturer's catalogue. We are also not responsible for the variations in tool life or breakage of tools because of the variations. in Customer's job material- properties, hardness, tensile strength, machine ability factor , poor conditions of the basic tool holders and it's spares / accessories, poor set up rigidity, poor conditions of coolant and chip evacuation, improper conditions of machines & erratic behavior of the electronic controls, slides, turret etc, and poor tool or job fixtures, selection of wrong speeds, feeds & depth of cuts by the customer's, extensive/ prolong utilization of the cutting edge and resulting breakage of tool / holders etc
